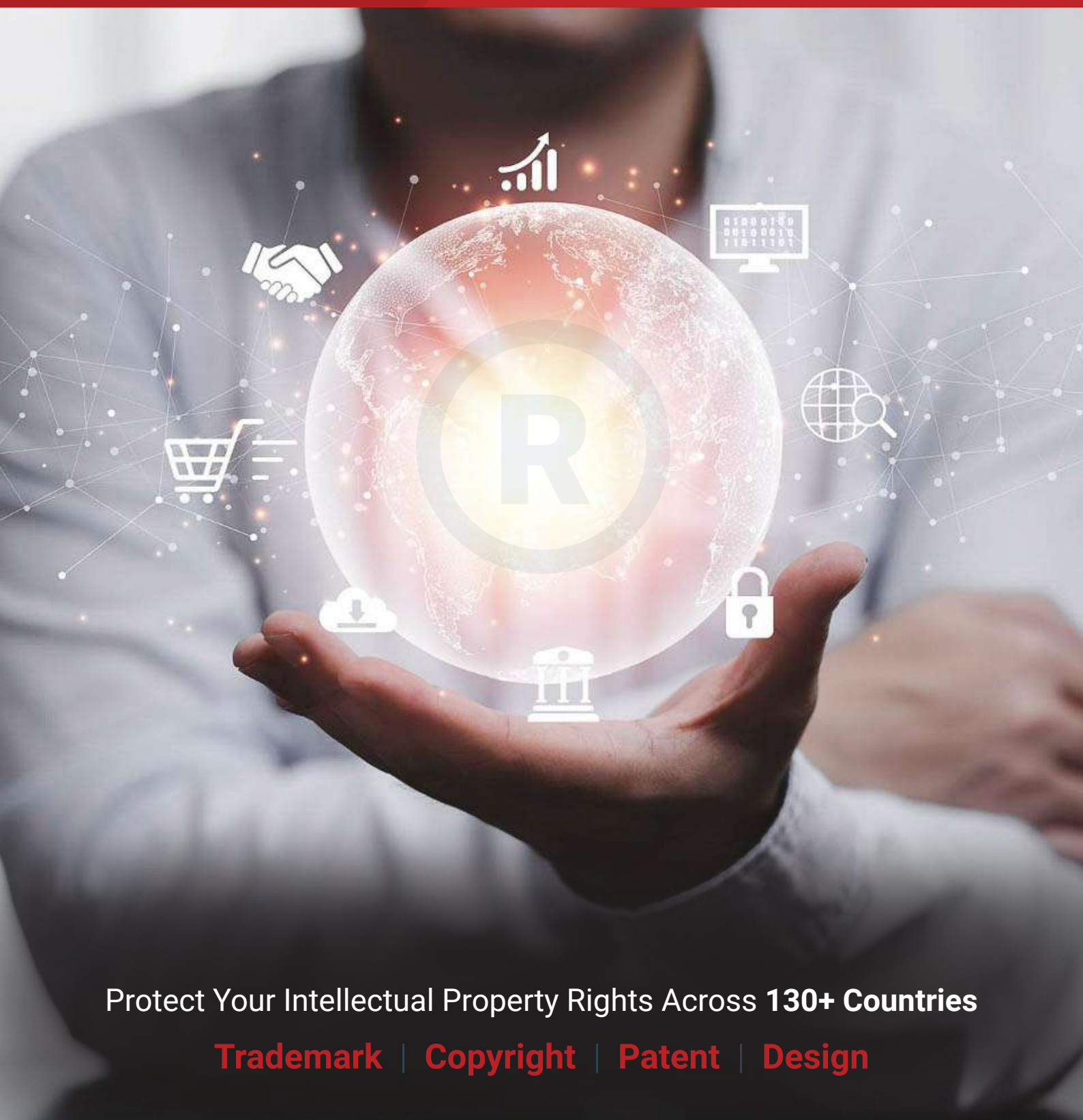

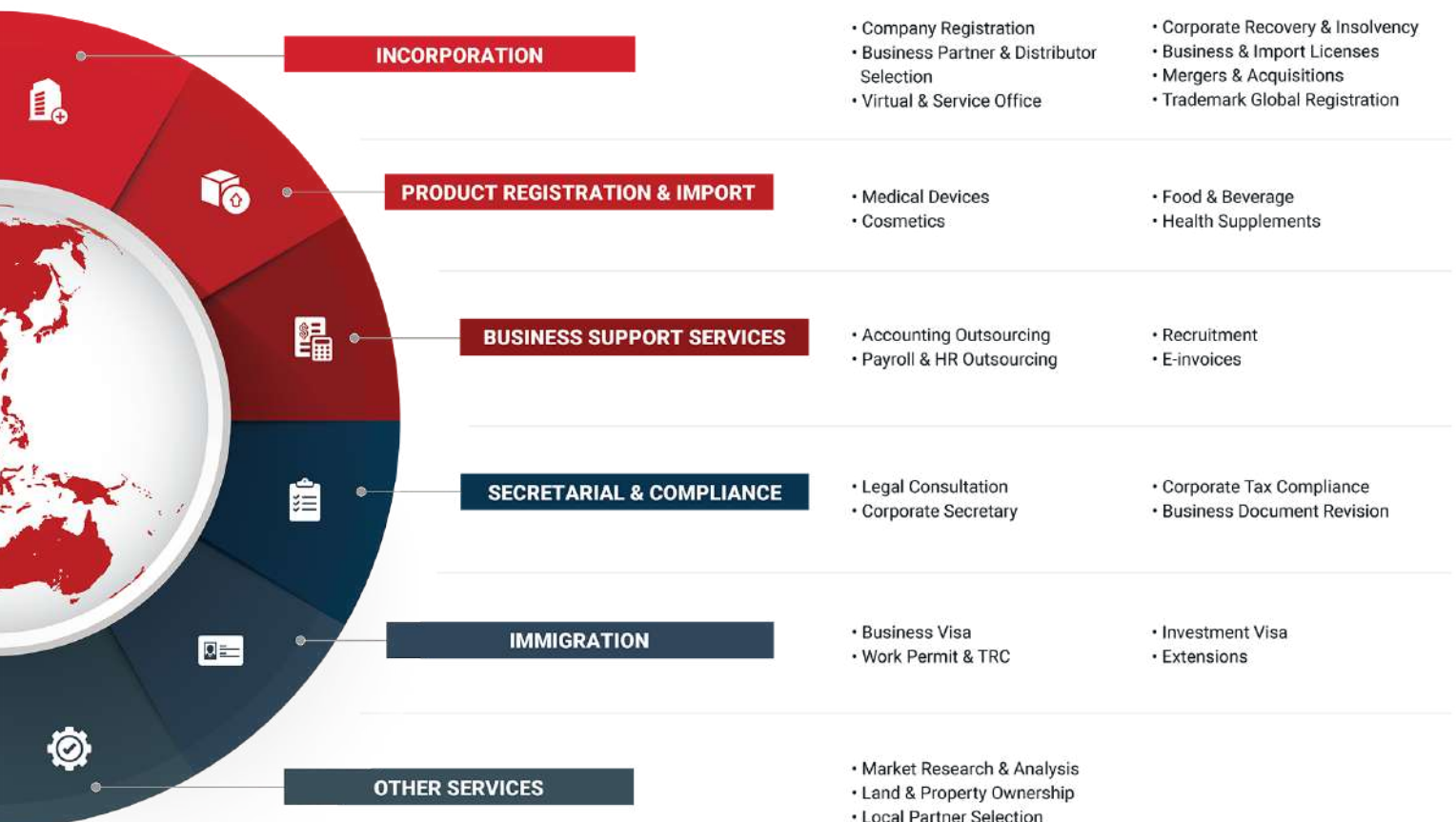

What Other IPs Do You Need to Protect?

Apart from trademarks, businesses may also need to protect other types of intellectual property (IP), such as patents, copyrights, and designs.

Patents protect inventions and give the owner the exclusive right to manufacture, use, and sell the invention for a certain period of time.

Copyrights protect original works of authorship, such as literary, musical, and artistic works, and give the owner the exclusive right to reproduce, distribute, and display the work.

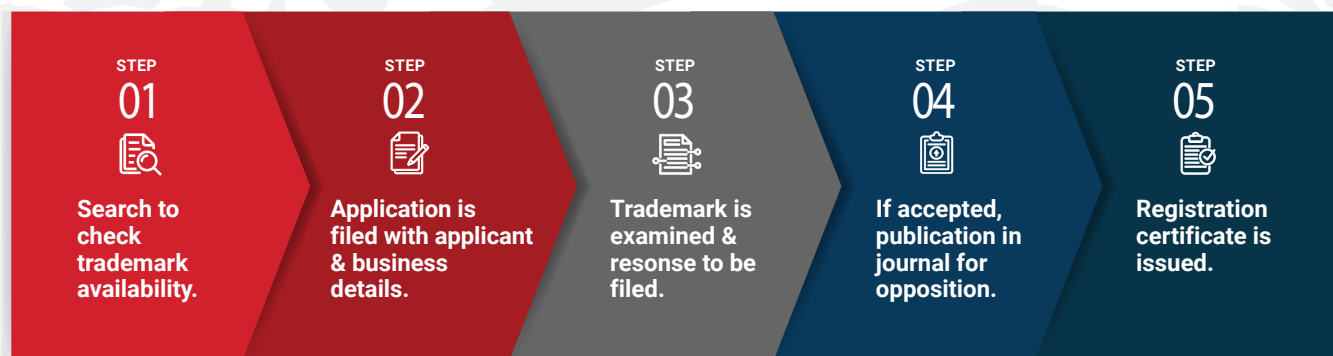
Designs protect the visual appearance of a product and give the owner the exclusive right to prevent others from making, importing, or selling products that look similar.

Trademark Filing Options: **Madrid & Direct**

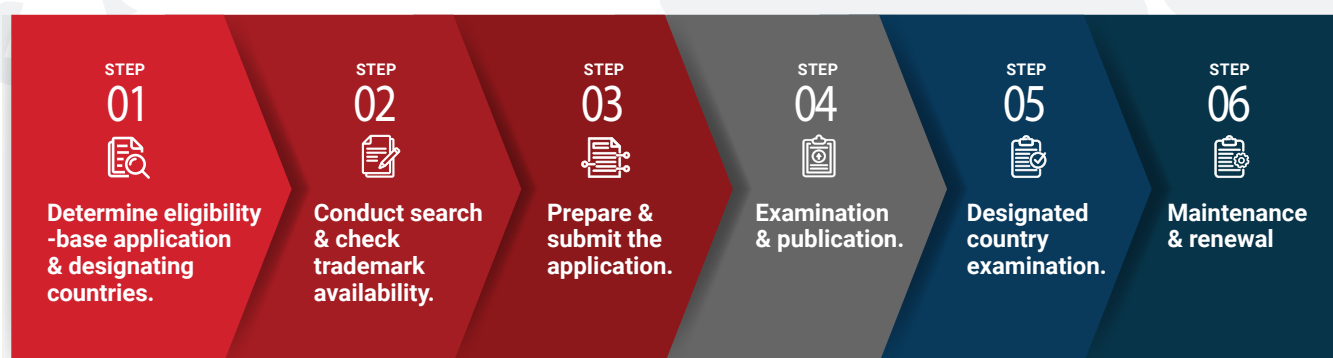
Madrid Filing*	Direct Filing
File a single application to cover over 130 countries	File separate applications for each country
Based on an existing national or regional trademark application or registration	Does not require an existing national or regional trademark application or registration
Simplified and centralised process through the World Intellectual Property Organization (WIPO)	Involves dealing with each country's national trademark office
Cost-effective as compared to filing separately in each country	Can provide greater flexibility and control over the filing process
Limited to countries that are members of the Madrid Protocol	Available to all countries, including non-Madrid Protocol countries
May have stricter examination and opposition procedures	Examination and opposition procedures may vary by country

** Note that under the Madrid Protocol System, before filing an international application, you must have first registered the trademark or filed an application domestically in the country of origin. A country of origin is a country that is a member of the Madrid Protocol where the applicant (person or entity filing the application) is a resident or national of or has a real and effective industrial or commercial establishment.*
